
2020 Annual Report



ADVOCACY & IMPACT

Legislation specifically targeting corporate housing continued in 2020, with \$90,365 spent on legilative monitoring and support of three market-specific leislative issues. Initially, the CHPA Board of Directors approved an assessment for member companies to support these challenges as an industry. In March 2020, the Board postponed this assessment and approved payment of lobbying costs for three initiatives. In April 2020, the Board halted all arrangements with lobbying consultants to contain costs as legislation focused on the pandemic. CHPA submitted letters to US and Canadian government officials requesting aid for the industry.



COVID-19 RESPONSE

CHPA reached out to healthcare and hospital associations to offer member inventory to frontline workers, resulting in more than 500 leads to member companies.
